
#### DIXON FIRE CELEBRATES 150 YEARS OF SERVICE

The Dixon Fire Department celebrated their 150th anniversary and Fire Prevention Week with an open house on Saturday, October 9.

Established in 1871, the Department has a long tradition of serving and protecting the Dixon community. The Department continues this today by providing a full range of emergency services 24 hours a day, 365 days a year. The Department serves a combined population of nearly 25,000, covering an area of 320 square miles. Seven square miles of service area are within the city limits and 313 are in the Dixon Fire Protection District through a protection contract.

The Department provides fire protection, paramedic level emergency medical response, fire prevention services, public fire safety education, fire investigations, and emergency management.

## PLANNING FOR THE FUTURE

#### **GENERAL PLAN 2040**

In May, the City Council adopted the Dixon General Plan 2040. Adoption of the General Plan was the culmination of an eight year long process, that went through some starts and stops.

The General Plan is the policy document that guides the growth and development of the City over the next 20 years. It is required by law in the state of California, and identifies current and future needs regarding land use, transportation, housing, open space, conservation, safety, noise, and environmental justice.

To help inform the General Plan, the City collected survey responses from over 600 residents, held multiple community workshops, formed a General Plan Advisory Committee and held numerous meetings with the Planning Commission and City Council.

With the recent adoption of the General Plan, the City will next be embarking on two long range planning initiatives, including updates to the City's Housing Element, Zoning Ordinance and Zoning Map.

#### HOUSING ELEMENT

The Housing Element is one of the required chapters in a City's General Plan and is required to be updated every eight years. The current housing element was not included in the general plan update because it is valid from 2015-2023.

As we near the end of term for the current Housing Element, the City is initiating the update for the next eight year period (2023-2031). This update process will commence in Fall 2021 and is anticipated to be completed by Summer 2023.

The City has partnered with multiple other cities in Solano County to hire a single firm to assist with the update, which allows for greater efficiencies and cost savings to the cities. Placeworks has been selected as the consultant to lead this effort.

## ZONING ORDINANCE AND MAP UPDATE

The City's Zoning Ordinance and Zoning Map are out of date. A comprehensive update and reorganization are necessary to bring them up to date and ensure consistency with the new General Plan.

The Zoning Ordinance is a day-to-day planning tool that implements the policies of the General Plan and establishes the specific development regulations for use (allowable use types) and development of a property (i.e. setbacks, height, parking, fence standards, etc.).

In July, the City issued a Request for Proposals (RFP) to solicit proposals from qualified firms to prepare the update. Six proposals were received, reviewed and ranked. In October, the City finalized an agreement with Miller Planning Associates and work on the update has started.

#### NATIONAL DAY OF SERVICE AND REMEMBRANCE


