



CITY OF DIXON ALL WEATHER SYNTHETIC PLAY FIELD RULES & REGULATIONS

It is the responsibility of the individual identified as the person on the permit to enforce the rules and regulations regarding the conduct of the group while using City of Dixon fields/facilities.

These rules include but are not limited to:

- City Facility Attendant will be on site during any field use.
- No food (including shelled nuts, sunflower seeds, peanuts, etc.) or chewing gum allowed inside the fenced turf area.
- No selling of food or other items inside the fenced turf area. No vendors of any kind allowed in the fenced turf area.
- Plain water bottles with water or a cooler with water permitted, on the concrete path only.
- No glass containers in the fenced turf area or any surrounding park area, including parking lots.
- NO alcohol in the fenced turf area or any surrounding park area, including parking lots.
- No form (e.g. chewing, smoking, vaping, etc.) of tobacco or cannabis allowed in the fenced turf area or any surrounding park area, including parking lots.
- No spitting on the turf area.
- All garbage must be dispensed into trashcans.
- No unapproved footwear. Metal spikes of any kind not allowed. Only clean (free of mud) molded plastic or rubber cleats (cleat ½" or smaller) tennis shoes or turf shoes allowed on the turf surface.
- No fireworks, barbecues, propane tanks, lighters or open flames, etc. allowed.
- No use of model planes or rockets allowed.
- No animals allowed inside the fenced turf area, with the exception of animals specifically trained to aid a person with a disability.
- No vehicles allowed; wheeled devices, including but not limited to motorized vehicles, bikes, wagons, inline skates, scooters and skateboards are not allowed inside the fenced turf area.
- No substantial training equipment such as blocking sleds and tires (for tire flipping) allowed on the turf surface.
- No unapproved chairs on the turf play field; Tables, chairs, canopies, shade structures, tents, etc. not allowed on the turf surface. Setting up or constructing any temporary structures, including but not limited to canopies and tents is prohibited.
- During athletic competitions, all spectators shall remain off the turf area.
- No painting, chalking, tape or other adhesive material of the turf field allowed. Temporary, short term marking may be allowed, but must be approved by the City of Dixon Parks Supervisor prior to use.
- No climbing on or moving of permanent goals allowed. This must be requested on the field request form prior to rental or usage. Moving of goals and other equipment, if needed, is done by authorized personnel only.
- Portable goals and/or markers may be allowed, but must be removed daily. Use of portable goals and/or markers must be approved by the City of Dixon Parks Supervisor prior to use.
- Only free standing field markers and sports equipment may be used on the turf surface. No stakes, posts, poles, pointed objects or markers of any kind may be driven into the turf surface.

- No hitting, throwing, or kicking balls into the fences, with the exception being fence/netting serving as uprights for football field goal posts. Field boundary fences are not to be used as backstops or goals at any time.
- No permanent signage allowed. Temporary, short term signage may be allowed, but must be approved by the City of Dixon Parks Supervisor prior to use.
- No storing of equipment, supplies, etc. in the fenced turf area.
- No golfing, shot putting, javelin or discus throwing or other non-authorized use allowed in the fenced turf area.
- No setting up or using a public address system and/or amplified music without prior written permission from the City of Dixon.
- Permits are not transferable.
- Field use begins and ends at the times on the permit, including inspections, set up and clean up. Groups will not allowed on the field prior to the start time stated on the permit and are required to exit the field and have adjacent areas cleaned up PRIOR TO the ending time indicated on the permit.
- Groups shall inspect the entire fenced turf play field area prior to and subsequent to each use to determine whether conditions are safe and/or appropriate for any intended use. Groups shall promptly advise the City of Dixon Parks Department of any unsafe/dangerous condition.
- Parking is restricted to designated parking spaces only. Parking is not allowed on the surrounding dirt areas.

Failure to fully comply with these rules will result in users being asked to leave and/or immediate cancellation of reservation. Damage to the facility may result in the City pursuing a claim against the permit holder's insurance (if applicable).

The City of Dixon reserves the right to refuse service to any participant, spectator, user, etc. who violates any policy, rules, procedure or regulation or engages in any verbal and/or physical abuse of City of Dixon staff.

Unauthorized users will be asked to leave. Failure to comply is subject to enforcement per Dixon Municipal Code 8.01.010 and the California Penal Code 602 (m).
